

# Privacy notice for Evaluation of Sutton Scholars 2016-19 cohort (code: STSC)

Updated 08/06/2020

#### 1. Why are we collecting this data?

The Sutton Trust ('The Trust') has commissioned NFER to evaluate its Sutton Scholars programme for the 2016-19 cohort, to assess whether the programme is meeting its aims. The Trust needs to evidence the effectiveness of its programmes to funders, donors and trustees. As a social mobility charity, The Trust also aims to demonstrate the impact of its programmes on social mobility over time.

To help them do so, NFER is investigating:

- the academic progress of students during the programme and whether their academic trajectory is maintained, improves or declines
- the attitudes of participating students towards education and their expectations for higher education
- the implementation and delivery process across programmes.

NFER will also compare the GCSE outcomes of these pupils with a group of matched pupils who did not take part in the programme.

Your data will be treated confidentially. We will not say anything in our reports that could identify you and will not use your data in a way that would affect you individually. We will not use the data you provide for marketing purposes or pass it on to any third party not involved with the delivery or evaluation of the programme.

# 2. Who is this research project sponsored and funded by?

The NFER is undertaking this research on behalf of the Sutton Trust (the Data Controller). NFER is the data processor.

# 3. What is the legal basis for processing activities?

The legal basis for processing personal data is covered by:

GDPR Article 6 (1) (f) which states that 'processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party except where such interest

are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of the personal data'.

The study contributes to The Trust's work improving social mobility in the UK through evidence-based programmes, research and policy advocacy and is therefore in its legitimate interests to investigate its effectiveness. You have the right to object to this processing if you wish, please see who to contact in Section 10 below.

### 4. How will personal data be obtained?

Students' personal data is obtained by the universities running the Sutton Scholars programme and then sent to The Trust. The Trust then sends personal data to NFER via secure portal, unless students or their parents have specifically requested for their data not to be included in the evaluation.

NFER will apply to the National Pupil Database for attainment data and the personal and school characteristics of students participating in the Sutton Trust programme and for the same information in de-identified form for the whole cohort in England.

#### 5. What personal data is being collected by this project?

The following types of personal data are being processed for participants in the Sutton Scholars programme:

- Name
- Unique Pupil number (UPN)
- Date of birth
- Gender
- Free school meals eligibility
- Whether the student is identified as a looked after child (LAC background)
- Whether the students' mother and father obtained a university degree
- Key Stage 2 attainment outcomes for: reading; grammar, punctuation and spelling; maths; writing; and science (provided by their teacher)
- Key Stage 3 outcomes for maths, English and science
- Whether the student is identified by their teacher as gifted and talented
- Whether the student is identified by their teacher as being in the top ten per cent academically of the year group
- Whether the student is on track to achieve 5 A\*-C grades at GCSE (provided by their teacher).

Attainment data and personal and school characteristics will be requested from the National Pupil Database for the pupils on the Sutton Scholars programme and for the whole cohort of students in England but in de-identified form in order to produce a matched sample of students for comparison with the Sutton Scholars.

#### 6. Who will the personal data be shared with?

The personal data of participants in the Sutton Scholars programme will be shared between the university providing the programme, The Trust and NFER. All data will be shared via secure portal and will be held securely.

# 7. Is personal data being transferred outside of the European Economic Area (EEA)?

No personal data is stored or transferred out of the EEA.

#### 8. How long will personal data be retained?

Most data will be held for one year following the completion of the evaluation, expected to May 2024. Some data is however required for longer, to track your future education outcomes and university and career destinations. We will then delete all identifiable information in accordance with NFER's internal policy.

#### 9. What rights do individuals have over their personal data?

NFER handles your personal data in accordance with the rights given to individuals under data protection legislation. If at any time you wish us to withdraw your data or correct errors in it, please contact the Sutton Trust at info@suttontrust.com.

In certain circumstances, data subjects have the right to restrict or object processing, please contact our Compliance Officer. They also have the right to see information held about them. NFER will cooperate fully when a subject access request (SAR) is made.
