## THE EUROPEAN UNION

The Maastricht Treaty signed in 1992 established a European Union (EU) consisting of three 'pillars':

- the European Community (based on a revised version of the Treaty of Rome);
- cooperation between Member States on common foreign and security policies;
- cooperation between Member States in justice and home affairs.

The EU works through four main institutions:

- the Council of Ministers;
- the European Parliament;
- the Court of Justice;
- the Commission.

These institutions act jointly to make regulations, issue directives, take decisions, make recommendations and deliver opinions.

- *Regulations* are binding and directly applicable in all Member States.
- *Directives* are binding in terms of outcome, but Member States are free to decide the means of achieving the desired outcome.
- *Decisions* are binding on those to whom they are addressed.
- *Recommendations* and *Opinions* have no binding force.

In January 1994, the European Economic Area (EEA) Agreement came into force, extending the EC's Single Market to the then European Free Trade Association (EFTA) states. The agreement also involved closer cooperation in other fields, such as education. The current EEA States are Iceland, Liechtenstein and Norway.

## **European Commission**

The Commission is the executive arm of the European Union and is divided into 24 Directorates-General. In the UK, the Commission has offices in London, Belfast, Cardiff, and Edinburgh. The London office has an information unit and a library.

The Commission now has a policy of decentralising the provision of information about the EU and is currently establishing national networks of information relays which can disseminate information effectively at a local level. These networks include, among others, the European Documentation Centres (page 16) and the Public Information Relay (page 126). An Education Relay is also planned.

## **Education and Training and the European Community**

Education was not originally included in the Treaty of Rome which established the European Economic Community; vocational training was included, since it was considered to contribute to the mobility of persons. Until 1993, collaboration between Member States in the field of general education depended on voluntary agreements. However, Article 126 of the Treaty of Maastricht amended the Treaty of Rome to bring education within the European Community's areas of competence. Legally speaking, when referring to Member States' joint activities in the fields of education and training, reference should be made to the EC rather than the EU.

In 1989, the Task Force: Human Resources, Education, Training and Youth was created to coordinate the activities of the Commission in the field of education. The Task Force has now become Directorate-General XXII (Education, Training and Youth).

The European Commission encourages cooperation between Member States in the fields of education and training; it also supports and supplements their work. Community activities in education are aimed at developing the European Dimension in education, particularly through the teaching of foreign languages, the mobility of students and teachers, the recognition of qualifications and the exchange of information. National governments retain responsibility for the content of teaching and the organization of their own education systems.

## **Community Action Programmes**

Community Action Programmes in the field of education and training have been simplified and rationalised into two new programmes, namely SOCRATES and LEONARDO DA VINCI.

SOCRATES is the new education programme and has three chapters. Chapter I deals with higher education and retains the title ERASMUS. Chapter II covers school education and adopts the title COMENIUS. Chapter III incorporates Horizontal Measures which supplement the Actions of Chapters I and II. The title LINGUA has been retained for Chapter III Action 1, which relates to the promotion of language skills. The EURYDICE and NARIC networks and the ARION programme have also been incorporated into Chapter III.

LEONARDO DA VINCI is the programme for vocational training. It replaces COMETT, EUROTECNET, FORCE and PETRA and incorporates some elements from the former LINGUA programme.

YOUTH FOR EUROPE III is the Community Action Programme designed for young people outside formal education and training structures.

EEA States participate in all Community Action Programmes and it is hoped that the Central and East European Countries (CEECs) will begin to participate in Programmes from 1997. The CEECs in question are Bulgaria, the Czech Republic, Hungary, Poland, Romania and Slovakia.

## **Community Initiatives**

Community Initiatives are proposed by the European Commission and funded through the Structural Funds (see below). They are designed to address problems common to a number of countries or regions in the European Union and are intended to promote more balanced economic and social development.

## Structural Funds

There are three structural funds: the European Social Fund (ESF); the European Regional Development Fund (ERDF); and the European Agricultural Guidance and Guarantee Fund (EAGGF).

The three Funds were reformed in 1988 to focus on five priority areas.

1. Promoting improvements in less developed regions
2. Assisting the development of regions in industrial decline
3. Combating long-term unemployment
4. Assisting workers to adapt to industrial change
5. Assisting the structural reform of agriculture and promoting the development of rural areas.

A sixth objective was introduced in 1995 to assist the new Nordic members.

6. Promoting the development of sparsely populated areas.

The European Social Fund allocates 80 per cent of its expenditure to training. Its main office is at the Commission in Brussels. The UK address is:

All previous activities under the inter-university cooperation programmes have been incorporated into the new programme.

**Action 1:** Promotion of the European dimension in universities through transnational co-operation, especially the development of inter-university programmes.

Activities financed include study periods abroad; promotion of the **European credit transfer system (ECTS)**; joint development of curricula; mobility of teaching staff; and short intensive courses for students from several Member States.

Other eligible activities include the incorporation of curriculum material which promotes the European dimension (including distance education) and the learning of European Union languages as an integral part of studies. Joint ventures among groups of universities cooperating with community groups or partners from industry may also be financed.

ECTS aims to solve the problems of academic recognition still existing between Member States as regards courses and periods of study and intermediate and final examinations. The system will enable students who are following a higher education training course, or have completed one, to receive a credit for the training undertaken in another Member State.

**Action 2: Student mobility**

Grants are available for students studying in another Member State for a period of between three months (or one term) and one academic year.
