



Evaluation of the Maths Excellence Fund: Privacy Notice for Programme Delivery Teams

1 Why are we collecting this data?

The Maths Excellence Fund ('the Fund'), managed by Purposeful Ventures, was set up to help more students join and stay on the maths excellence pathway. The Fund has been established to improve student attainment and progression in maths, increasing the number of students who are on track to succeed in A-level maths and beyond. It has a particular focus on high potential students from disadvantaged backgrounds, for whom studying maths can unlock significant opportunities. The Fund is currently supporting four programmes being delivered by Inspiration Trust, Mathematics in Education and Industry (MEI), Co-operative Academies Trust and United Learning. The Fund has commissioned the National Foundation for Educational Research (NFER) to carry out an evaluation of the four programmes. You represent one of these programmes and have agreed to participate in the evaluation.

Phase 1 of the evaluation will take place from June 2024 to July 2026, covering the first two years of the programme delivery. The focus will be on the implementation of the programmes. There will be a Phase 2 of the evaluation which will take place from September 2026 to December 2029, focusing on the impact of the programme.

This document outlines how your personal data will be collected and processed for Phase 1 of the evaluation. This data will be securely stored and also used in Phase 2. As a member of one of the teams delivering one of the programmes you have agreed to be interviewed about progress in delivery (for example, what is working well and less well and areas for development).

Separate privacy notices cover the data that each of the four programmes will collect to enable delivery of their programme and its on-going implementation. The privacy notice for each programme will be made available before the programme starts and can be accessed here when available.

For the purpose of this document, we will refer to the four above programmes as 'programme delivery teams'.

We will treat all staff personal data with the strictest confidence, and it will be processed in accordance with the UK GDPR and the Data Protection Act 2018. We will not use your name or any information that might mean someone could identify you in any reports about the results of this evaluation.

2 Who is the data controller?

NFER is the data controller for the evaluation and makes decisions about what personal data is and how it is processed in accordance with the objectives set by the Fund.

Personal data will be processed to deliver the programme. Programme delivery teams are responsible for making decisions about how that data is processed and they are the data controllers for programme implementation. Their privacy notice is available above in Section 1.

The Fund will become data controller once the data is archived (see Section 8).

3 What is the legal basis for processing activities?

The lawful basis for processing personal data is covered by GDPR Article 6 (1) (f):

Legitimate interests: the processing is necessary for your (or a third party's) legitimate interests unless there is a good reason to protect the individual's personal data which overrides those legitimate interests.

A legitimate interest assessment has been undertaken. The evaluation fulfils one of NFER's core business purposes (undertaking research, evaluation, and information activities). It has broader societal benefits and will contribute to improving the lives of learners by providing evidence about the impact of teaching techniques used in the classroom. Research cannot be done without processing personal data, but processing does not override the data subject's interests.

4 How will personal data be obtained?

You have been asked by the Fund or other members of the programme delivery team to participate in an evaluation interview which will be held online. If you agree, you will share your contact details with NFER via email, which will be used to organise an interview. Further personal data will be collected directly from you during the interview.

5 What personal data is being collected by this project?

The following personal data will be collected about you:

- Name
- Programme
- Role
- Email address
- Telephone number.

During the interview, information about your perceptions of the implementation and impact of the programme will be collected.

6 Who will personal data be shared with?

Your personal data will not be shared with anyone beyond the project team at NFER.

Comments made about unique elements of the programmes could be identifiable, but individuals will not be named in any published reports of our evaluation findings.

7 Is personal data being transferred outside of the UK?

NFER only stores personal data in the UK.

When we use Zoom data may be stored outside of the UK. Any such transfer is safeguarded by appropriate safeguard, for example, and adequacy decision or contractual obligation to protect your information to the standard required in the UK. Please contact us for further details.

8 How long will personal data be retained?

NFER will delete any personal data collected as part of the evaluation within one year of publication of the final Phase 2 evaluation report. This deletion process is currently planned for December 2030.

The Fund intends that evaluation data will be archived when Phase 2 of the evaluation is complete (August 2029) to allow for further research. Plans have not yet been finalised but archiving of evaluation data will comply with and meet the requirements of data protection legislation.

9 Can I stop my personal data being used?

NFER handles personal data in accordance with the rights given to individuals under data protection legislation. Under certain circumstances data subjects have the right:

- to request access to information that is held about them (a data subject access request).
- to have personal data rectified if it is inaccurate or incomplete.
- to request the deletion or removal of personal data where there is no compelling reason for its continued processing.
- to restrict processing of personal data (for example, permitting its storage but no further processing).
- to object to processing
- to data portability
- not to be subject to decisions based purely on automated processing where it produces a legal or similarly significant effect.
