## Inspiring Futures Evaluation Privacy Notice for Charity Leads

---

### 1 Why are we collecting this data?

The National Foundation for Educational Research (NFER) has received funding from The Rigby Foundation to undertake an evaluation of the Inspiring Futures programme. Inspiring Futures is supporting schools and colleges to provide students with mental health and wellbeing support, academic tutoring, skills development, and guidance and experience for post-16 pathways.

As part of this evaluation, we will contact charity leads to collect programme-level data about young peoples' participation and outcomes. We will also email charity leads with updates on the evaluation process and updates.

This document outlines how information about you (known as **personal data**) will be collected, used and kept safe for the purposes of this research.

### 2 Who is this project sponsored and funded by?

This work is being carried out by The National Foundation for Educational Research (NFER), on behalf of The Rigby Foundation, the data controller. For the purpose of data protection legislation, NFER is data processor. NFER will process personal data in accordance with the evaluation aims agreed with The Rigby Foundation.

### 3 What is the legal basis for processing activities?

To process this personal data, the legal reason for collecting or processing this data is:

6 (1) (f): *Legitimate interests: the processing is necessary for your (or a third party's) legitimate interests unless there is a good reason to protect the individual's personal data which overrides those legitimate interests.*

A legitimate interest assessment has been undertaken. The evaluation fulfils one of The Rigby Foundation's legitimate interests by helping them to report on their charitable activities, to improve the work of the charity and operate it efficiently. Specifically, it will help to understand the implementation and impact of the Inspiring Futures programme, and to improve the programme for future years.

This research cannot be undertaken without processing personal data. The Rigby Foundation and NFER will ensure your rights are protected.

## 4 How will personal data be obtained?

The Rigby Foundation will share the name and work email of the charity Inspiring Futures lead with NFER, so that we can contact you to collect aggregated data from your charity on Inspiring Futures participation and outcomes.

## 5 What personal data is being collected by this project?

The Rigby Foundation will share the following information about the Inspiring Futures charity lead:

- Name
- Work email address

## 6 Who will my personal data be shared with?

No charity staff personal data will be shared with anyone beyond the research team at NFER. We will write publicly available reports about our research findings, but no individuals, schools, colleges or charities will be named in these reports.

## 7 Is personal data being transferred outside of the UK?

NFER only stores personal data in the UK.

## 8 How long will personal data be retained?

NFER will delete any personal data collected as part of the evaluation one year after we publish our final report about what we find. This deletion process is currently planned for September 2029.

## 9 What are my rights in relation to personal data?

The Rigby Foundation and NFER handle personal data in accordance with the rights given to individuals under data protection legislation. Under certain circumstances data subjects have the right:

- to request access to information that is held about them (a data subject access request)
- to have personal data rectified if it is inaccurate or incomplete
- to request the deletion or removal of personal data where there is no compelling reason for

- its continued processing
- to restrict processing of personal data (for example, permitting its storage but no further processing)
- to object to processing
- to data portability
- not to be subject to decisions based purely on automated processing where it produces a legal or similarly significant effect.

The Rigby Foundation may need to request specific information from you to help us confirm your identity and ensure your right to access the information (or to exercise any of your other rights). This helps ensure that personal information is not disclosed to any person who has no right to receive it.

## 10 Who can I contact about this project?
